RESOLUTION NO. 2013-038

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF CORAL SPRINGS, FLORIDA, CONSENTING TO THE EXERCISE OF CERTAIN SECURITY POWERS BY THE TURTLE RUN COMMUNITY DEVELOPMENT DISTRICT PURSUANT TO SECTION 190.012(2)(d), FLORIDA STATUTES; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Commission adopted Ordinance No. 86-163 establishing the Turtle Run Community Development District (the "District"), as amended by Ordinance Numbers 90-124 and 2005-104; and

WHEREAS, the District has filed a Petition for Consent to Exercise Certain Special State-Granted Charter Powers requesting that the City consent to certain security powers specifically set forth in Section 190.012(2)(d), Florida Statutes in order to allow the District to place security cameras and fences at various locations throughout its boundaries, subject to approval of the City, and to have security patrol; and

WHEREAS, the District has requested consent for placement of the cameras in an effort to deter criminal activity and mischief throughout Turtle Run, provide an additional mechanism to assist local law enforcement in solving crimes occurring within the District and to provide an evidentiary basis to support the recovery and repair of any damages resulting from such activity; and

WHEREAS, City staff has reviewed the District's Petition and concurs that consenting to specific security powers by District for security cameras, fences, and security patrol would be beneficial in deterring crime within the City; now, therefore

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL SPRINGS, FLORIDA:

<u>Section 1.</u> The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and hereby made a specific part of this Resolution.

Section 2. The City Commission hereby consents to the exercise of certain security powers by the Turtle Run Community Development District pursuant to Section 190.012(2)(d), Florida Statutes, which powers shall be limited to security cameras and fences that meet all City Codes, and security patrol for any lawful purpose in accordance with Florida law on any private street.

<u>Section 3.</u> The City Commission may revoke its consent to these certain security powers when deemed in the best interest of the City.

Section 4. Should the District wish to exercise any other security power pursuant to Section 190.012(2)(d), Florida Statutes, including the use of guardhouses or gates, the District must petition and obtain consent from the City.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon adoption.
